

**SIGNATURE DOCUMENT FOR
DEPARTMENT OF STATE HEALTH SERVICES
CONTRACT NO.**

I. PURPOSE

The Department of State Health Services (“System Agency”) and Walgreen Co. (“Contractor”), (each a “Party” and collectively “the Parties”) enter into this contract to provide out-patient prescription drug services to Texas residents who are victims and/or evacuees of a disaster or emergency event (Event) causing them to reside in medical shelters, general population shelters, or other temporary residence/shelter, but not hospitals, in Texas. For the purpose of this Contract these Texans are referred to as “Shelter Residents.”

II. LEGAL AUTHORITY

This Contract is authorized by and in compliance with the provisions of Texas Health and Safety Code Chapters 12 and 1001 and Texas Government Code Chapter 531, Subchapter D, to the extent applicable.

III. DURATION

The Contract is effective on August 30, 2017 and terminates on August 31, 2019 renewed or terminated pursuant to the terms and conditions of the Contract.

IV. BUDGET

Contractor will not exceed payment rates at the effective Medicaid rate, as defined by DSHS and terms and conditions for that Event as outlined in **ATTACHMENT B, CONTRACTOR OPEN ENROLLMENT RESPONSE.**
